

**ACORD  
CU PRIVIRE LA PRELUCRAREA DATELOR CU  
CARACTER PERSONAL**

Prin semnarea prezentului acord, \_\_\_\_\_, declara ca a fost informat si si-a exprimat consimtamantul expres cu privire la urmatoarele aspecte, privind prelucrarea datelor cu caracter personal:

- ❖ Prelucrarea datelor cu caracter personal se realizeaza de catre **Z EXECUTIVE HOTEL SRL (denumita in continuare Z HOTEL)**, persoana juridica romana, cu sediul social in Bucuresti, Sector 3, Str.
